# **BOARD OF HEALTH**

The Polk County Board of Health met in the conference room of the Health Department at 10:00 AM on December 14, 2010.

Chairperson Schmidt called the meeting to order.

Motion by Dr. Lagus/Johnson to approve the agenda. All in favor. Motion carried.

Motion by Johnson/Nelson to approve the minutes of the November 16, 2010 Board of Health meeting. All in favor. Motion carried.

### **Monthly Bill Review**

Sampson reviewed the list of bills and answered any questions.

# Motion by Dr. Lagus/Johnson to approve the bills in the amount of \$30,099.24. All in favor. Motion carried.

# **Monthly Statistical Reports**

Sampson handed out the monthly statistical reports for review.

# **Out of County Meetings**

Sampson reviewed the list of out of county meetings and trainings for December and January.

Motion by Scoglio/Kremer-Hartung to approve the out of county travel. All in favor. Motion carried.

# Old Business

# 1) Approve Lease Vehicle Bids

Four bids were submitted for the prepaid vehicle lease. Neuville Motors at \$12,200 per vehicle. Ken Vance Motors at \$10,027 per vehicle. Bernard's at \$12,495 per vehicle and Johnson Motors with an open ended purchase agreement.

# Motion by Scoglio/Kremer-Hartung to accept the bid from Ken Vance Motors in Eau Claire for the 2 prepaid lease vehicles. All in favor. Motion carried.

### 2) Follow up on Preparedness Consortium Changes

The Board was provided with a copy of the letter submitted on behalf of the preparedness consortium to various state health department officials regarding the decision to phase out the preparedness consortia. Jason Shrader gave an update on the issue. The Consortium hopes to continue contracting with Western Region counties and tribes, and the consensus is that these entities still want this service but cannot commit to budget dollars at this time.

### 3) Results of the first round of the CAHPS surveys in Home Care.

Hodgson discussed new Medicare Regulations including PT re-assessments needing to be done at specified time points; new codes for specific services and Face to Face encounters with physicians and the corresponding hand written notations that Physicians will be required to write that will be mandatory before Home Care visits can be billed. Some of these regulations take effect 1-1-2011 but the PT regulations are delayed until April 2011. The board discussed ways to assist in getting a delay for the Face-to Face regulations and Sampson will check if there is an opportunity for advocacy, and possibly draft a letter from the board to legislators or provide a web address for them to write individual letters.

#### **New Business**

# 1) Prevention Grant Application for Accreditation Work

Sampson was notified that Polk County will be awarded a \$33,000 grant for developing templates for LHDs and tribes to meet PHAB accreditation documentation requirements. The grant will start January 1, 2011 and is a year long project.

# 2) Update on new Medicare Regulations for Home Care

Hodgson discussed new Face to Face encounters between clients on service and their physician within 30 days of start of care that will be mandatory before Home Care visits can be billed. There are also new requirements for therapy services. Sampson will check if there is an opportunity for advocacy, and possibly draft a letter from the board to legislators about the difficulties this regulation poses for local home health providers and physicians.

# 3) Appointments of Citizen members to BOH

An outline of job responsibilities, expectations and qualifications was distributed highlighting the purpose, mission, statutory responsibilities, and expectations of new board members. Term limits for citizen members were discussed at ideally being set to 3 terms/6 years. Dr. Lagus has been on the board for 12 years, Wanda Johnson, RN, 10 years and Rick Scoglio 6 years. These recommendations were expressed to Dana Frey the Administrator as he decides on citizen members as well as staggering terms when citizen members are appointed or reappointed.

# 4) Department Influenza Program

Due to the changing dynamics around influenza vaccination, Sampson discussed focusing the influenza program on children and staff in Polk's schools, cutting down on community clinics and amending the budget to reflect reduced revenues. Due to

School clinics will still be done, as well as walk-in clinics, needy low income clients, and Home Care patients.
