The Polk County Board of Health met in the conference room of the Health Department at 10:06 AM on August 10, 2010.

Chairman Schmidt called the meeting to order.

Motion by Johansen/Johnson to approve the agenda. All in favor. Motion carried.

Motion by Johnson/Kremer-Hartung to approve the minutes of the July 13, 2010 Board of Health meeting. All in favor. Motion carried.

#### **Old Business**

### **Jail Medical Advisor Update**

Gretchen Sampson reviewed a pending contract with St. Croix Regional Medical Center regarding medical advisor services. Jeff Fuge has been involved in reviewing the tentative contract. The contract will be between the Sherriff's Department and SCRMC. There will be reimbursement for physician consultation time as well as any time spent on court cases. Inmates will still be transported to St. Croix Regional Medical Center for treatment. If indicated, the County would continue to be charged Medicaid rates, to be paid by the Jail.

#### **Smoke Free Air Ordinance**

Sampson presented a draft of a county ordinance on smoke free air. Corporation Counsel Jeff Fuge gave an overview of the local ordinance and why a local ordinance would make it easier for Law Enforcement and the District Attorney to enforce. Laura Jurek who works on the MJC Tobacco Coalition attended and also answered questions regarding the County ordinance and the State Law. A recommendation was made to send a resolution to the County Board to authorize a public hearing on the proposed ordinance.

Motion by Dr. Lagus/Johansen to send resolution to County Board to authorize public hearing on proposed ordinance. Lagus/Kremer-Hartung/Nelson/Johnson/Schmidt/Johansen in favor.

Rick Scoglio opposed. Motion carried.

#### **Monthly Bill Review**

Sampson reviewed the list of bills and answered any questions.

# Motion by Johnson/Scoglio to approve the bills in the amount of \$49,568.94. All in favor. Motion carried.

#### **New Business**

#### 1) Presentation of 2011 Budget

Sampson discussed the department's 2011 budget goals and objectives and briefly explained the levy changes for each program. Dana Frey was also present to answer any questions and stated that September will be the final budget recommendation to the County Board. Frey expressed appreciation for the format of the budget presentation and thought it was helpful for the board to better understand the major changes and issues with the department levy budgets. Kremer-Hartung asked for a list of what is mandated by the state. Frey stated that all departments will soon be required to complete a program overview with that information included and it should be available for the next BOH meeting.

#### **Monthly Statistical Reports**

Sampson reviewed the Budget Overview Report for July for the Public Health Programs as well as the June statistical reports for Public Health programs including communicable disease and animal bites. Bonnie Leonard discussed Anaplasmosis and their new process for receiving reported cases from medical clinics. Sampson also reviewed the Home Care Program statistical, revenue and expense reports for June.

# Motion by Kremer-Hartung/Johnson to approve the statistical reports. All in favor. Motion carried.

#### **Out of County Meetings**

Sampson reviewed the list of out of county meetings and trainings for August and September.

# Motion by Johansen/Scoglio to approve the out of county travel. All in favor. Motion carried.

#### New Business Birth to 3 Program

Sampson reported that the Birth to 3 Program needed the board's approval to purchase an EroScan portable hearing screener for their program. They received 2 bids for the equipment quoted around \$6400. The money will come out of the grant fund and no money is needed from the levy.
