Finance Committee met at 1:15. Larsen and Gates reviewed and signed vouchers.

Meeting was called to order by Larsen at 1:30pm. Pat Schmidt was introduced to the group and the group did introductions of themselves.

# **Financial Report and Bills**:

Flom passed out the 2010 financial reports (dated May 2010) and the current billing (dated July 20, 2010) as reviewed by the Finance Committee. # **Old Business**:

Northern Bridges: last date of service: The last date of service for Northern Bridges will be July 20, 2010. The letter from Northern Bridges was shared with the group. Discussion was held on the discontinuing of service to Northern Bridges clients.

Workers Compensation insurance: Flom has a meeting with Jeff Fuge, Corporation Counsel for Polk County in regards to the topic of Workers Compensation Insurance. Flom will report back to the board at the September meeting.

Chippewa County vehicle: The vehicle has been received and is in service. The van was purchased from Chippewa County for \$7872.

# **New Business**:

Non-Profit Directors & Offices and Employment Practices Liability insurance renewal: Discussion was held on the renewal of the insurance for the board. The information was given to the board members.

5310 Grant: update: No word yet on the 5310 grant from the Department of Transportation. The larger vehicle has been pulled from the grant request due to the receiving of the Chippewa County vehicle.

Vehicles up for bid: Flom has contacted the state and requested release of both vehicles. Once the release from the state has been received the two vehicles will be put up for bid through the sealed bid process. Discussion was held on having a minimum bid posted in the public ad. The discussion led to the amount of \$500. Flom (or designee) will find the blue book value and speak with the Chair regarding a minimum bid amount.

Driver update: training: The drivers will be taking part in a fall training being offered by another county. The training is part of the annual training required of human service vehicle drivers.

Board update/observations/comments: Flom distributed a copy of a letter sent to all care facilities regarding the need for another lift-equipped transportation company for Northern Bridges clients. A letter was also shared in reference to Medicare and Supplements paying for non emergency transportation.

Mike Seversen is in Colorado at a care facility. He was in the Cities but has transferred to Colorado. His mother Kitty is undergoing health issue right now so the family is in our thoughts.

Discussion was held on having the meeting on the 4<sup>th</sup> Tuesday of the month due to County Board taking place on the 3<sup>rd</sup> Tuesday of the month. All present felt the change would be fine so the next meeting will be the 4<sup>th</sup> Tuesday of September.
