Dean Johansen called meeting to order at 9:32 am.

<u>Approved Agenda</u> - Motion by Jepsen; seconded by Brown to approve the agenda. Motion carried by unanimous voice vote.

Minutes of Last Meeting.

Motion by Brown; seconded by Johnson to approve the minutes of the November 10th, 2010 meeting; motion carried by unanimous voice vote.

Reconvene Dog Claim – Deliberations on Requisite Findings – 11:15am

Making Requisite Findings of Investigation and Recommendation to County Board on Claim:

- Motion by Brown; seconded by Jepsen that previous motion made on November 10, 2010 stands that, based on evidence presented here today, there is insufficient evidence that dogs forcibly entered enclosure; carried by unanimous voice vote.
- Motion by Johansen; seconded by Jepsen that committee makes a finding based upon evidence submitted by claimant that dogs caused the death of three (3) deer; Roll call vote: Brown-yes, Jepsen-yes, Johnsonyes, Johansen-yes, Rattel-yes; carried unanimously.
- Motion by Jepsen; seconded by Rattel that the Committee makes a determination that the buck, scoring in the 170's Boone and Crockett, has a fair market value of \$1,500.00; carried on a 3-2 voice vote with Johnson and Johansen dissenting.
- Motion by Jepsen; seconded by Brown, that the Committee makes a determination that the two bucks, having a Boone and Crockett score of 182 and 183, have a fair market value of \$1,750; carried on a 3-2 voice vote with Johnson and Johansen dissenting.
- > Fuge will draft formal findings and resolution and bring to committee in January.
