Frey spoke on Resolution to Authorize A One-Time Temporary Equity Pay Adjustment to Non-Represented Employees.

Frey stated the 2012 budget amendments are to be in by October 13<sup>th</sup>.

Frey reported that he had received a letter from the Polk County Housing Authority to terminate the contract we have with them. He plans to ask Wisconsin Regional Planning for help.

Treasurer Amanda Nissen handed out and discussed her office update. Nissen also stated she had posted an RFP for Banking Services.

Nissen updated the committee on monthly reports on outstanding tax certificates, interest earned on tax certificates, investments, cash balance, and monthly interest on the county's checking account.
