Motion by W Johnson / Masters to accept the agenda; carried by voice vote. Motion by N Johnson / Masters to approve the minutes of September 29th, 2010 meeting; carried by voice vote.

Public comment None.

Committee calendar / agenda(s). Next finance committee meeting is October 11th, 2010 at 2:00 p.m. Finance meeting for October 13th has been canceled. County board meeting is October 12th, 2010 at 6:00 p.m.

County Board Chairman William Johnson spoke on be half of the International Trade, Business and Economic Development Council (ITBEC). Chairman William Johnson stated \$9,000 is in 2011 funding. This is not a levy request. Funding comes out of the Parks Dedication fund.

Parks and Buildings

Finance Director Maggie Wickre discussed the furnace needed for the office at the lime quarry. Parks and Buildings Director Deb Peterson received bids from Osceola Plumbing for \$5,926 and Maxwell heating \$8,120. Ms. Wickre stated funds will come from the quarry accounts so they can depreciate the expense.

Motion by Masters / N Johnson to authorize to move forward with funding; carried by voice vote.

Treasurer's office

Treasurer Amanda Nissen handed out and discussed her office update. The treasurer's office has offered to work out payment plans with property owners who have delinquent 2007 property taxes. This program has been well-received; the office has received over a dozen written requests for payment plans, more than half of them opting to have the payment made by automatic deduction from a checking or savings account.

Ms. Nissen stated they are catching up the filed deeds and getting started with information on the next tax season going out to the local municipalities today.

Finance committee minutes

Amanda Nissen updated the committee on monthly reports on outstanding tax certificates, interest earned on tax certificates, investments, cash balance, and monthly interest on the county's checking account.

- Outstanding tax certificates of \$579,388.26 were paid off during September;
- Interest earned on tax certificates was \$73,357.51.
- Monthly interest on checking account at 0.8% was \$3,508.34.

Budget appeals

Chairman Gary Bergstrom discussed budget appeals from September 29th, 2010 finance meeting.

• Economic Development Corporation: Motion by N Johnson / W Johnson to increase funding by \$10,000.00 to \$35,000 and to ask for specific actions and goals for 2011, plus a report with the 2012 budget request on what was achieved in 2011; carried by voice vote.

Motion by Masters/ W Johnson to direct Dana to consider the consolidation of funding for external agencies and bring a plan back to finance; carried by voice vote.

- Audio video equipment: forward to county board.
- Adult Development Center: Motion by Masters/ W Johnson to reduce rent by \$9,600.00 for a 1-year lease only: carried by voice vote.
- WestCap seeks renewal of operational funding in the amount of \$4,000: Motion by N Johnson / Masters to donate \$2,660; carried by voice vote.

County Administrator.

County Administrator Dana Frey presented information on revenue policy issues in the 2011 budget. Mr. Frey handed out and discussed new construction 2009 – 2010 and change in equalized value in Polk County.

Committee Observations

Motion by N Johnson / W Johnson to require a 3-year plan to increase undesignated fund balance up to 20% as required by county polity. The plan will include controlled expenditures and the expected decrease in delinquent taxes.

Supervisor Neil Johnson requested County Administrator Dana Frey to look at personnel cuts in heavy equipment operators at highway department and at office help and investigators in the sheriff's department. Mr. Johnson requested Mr. Frey to speak with department heads to cut staff and have results and findings to finance committee on October 11th, 2010.

Motion by N Johnson / W Johnson to adjourn; carried by voice vote.
