#### Overview of proposed HSD software

Todd Demers, Information Technology Department Head, explained the purpose of the new Human Services software that we are anticipating to purchase in 2013. Currently Human Services process flow has 4 systems that are not linked and offers very poor reporting. The current system allows for errors and is labor intensive as up to five people are doing the same entry of the same data. Our goal is to have a system where the data is streamlined and more efficient by only entering it once. The purchase of this software is budgeted in the Asset Protection and Internal Investment Fund in 2013.

# Resolution to Adopt the Polk County Operating and Capital budget for the calendar year 2013 and to set the 2013 tax levy

Dana Frey, County Administrator, introduced the recent Public Protection Committee amendment to the 2013 budget that is asking to provide \$25,000 to the drug court out of the fund balance in 2013. Dan Steffen, District Attorney explained that the request for the drug court would be matched next year for \$25,000 from the Bremer Foundation.
