Human Services Update

Board chair Stroebel called on Gene Phillips as the new Director of the Human Services Department to go over an update on Human Services. Gene Phillips stated he has some ideas on what the board would possibly like to see at these meetings. He would like to bring forward the great programs that are offered in the Human Services Department and share the information with the board. He then asked the board what direction they would like the meetings to go. The board agreed that they would like a monthly snapshot of the department presented to them at each meeting including statistics on the programs. They would like employees to give a presentation only if there is a new program, or something extraordinary to present about a program. All board members agreed upon a 2 hour timeframe for the monthly board meeting.

Client Satisfaction Results Survey

Gary Erich, a counselor for Human Services Substance Abuse program passed out a handout with results to a client satisfaction survey that is done annually. William Alleva asked how Drug Court is going. Gary's response was "great". He stated that he is working with his highest number of clients to date. They just received approval for a new grant to help fund the program. He said we should be able to add more resources for our clients. Drug Court started 4 years ago with 6 clients. Currently there are 16 clients on the program, and others on a waiting list as they are still in jail or treatment pending their release. Gary reported that the survey was consistent with other years, with an overall satisfaction from the clients. We received back 89 surveys from clients who have completed programs within the Substance Abuse program. We have not been able to capture the others whom have not completed their programs as they will not send the paperwork back. Human Services have made some changes offering the survey in the waiting room hoping to hear from a wider variety of clients along with any other suggestion/comments on the program.

Monthly Statistics

Pat handed out monthly statistics to all board members. It was discussed that ES was not on the report and Pat was certain that they were done, but must not have made it to Shelby in time to get on this report. Dr Markert asked if anyone could update on how Adult Protective Services is going. Kay Confer reported that things are going good and that the referral numbers have gone up in the last few weeks in APS, along with the other units also. William Alleva spoke about the diversion from the courts and how that affects Human Services. Kay stated that there are 11 teenage children that are now on our Mental Health caseload.

Next Meeting Date/Refreshments

The next Human Services Board meeting is scheduled for March 27th, 2012 @ 8:30 a.m. George Stroebel will not be in attendance at next months meeting as he will be out of town. Dr Markert will be providing refreshments at the March Meeting.
