Wildlife Damage Program

2012 Bear Trapping Agreement: Blonk reviewed the 2012 annual agreement between Polk County and Wildlife Services for the bear trapping agreement. Motion (Johansen/Johnson) to approve Cooperative Service Agreement between Polk County and United States Dept. of Agriculture Animal and Plant Health Inspection Service (APHIS) Wildlife Services.

Program Update: Blonk discussed the appeal that was dropped by D. Lauritsen.

Resolution to Authorize WDNR TRM Grant Funding: Ritten discussed the Targeted Runoff Management grant application for Mabry manure storage. The same resolution was allowed last year. **Motion (Jepsen/Johnson), to authorize application for Wisconsin Department of Natural Resources Targeted Runoff Management grant funding. Motion carried.**

Voucher Review and Financial Reports: Voucher report was discussed.

Agency Report:

FSA: Aaron Moore discussed the Conservation Reserve Program (CRP) signup ending on April 16. Many landowners are taking lands out of CRP. Also discussed the county committee election coming up for southern Polk County.

Directors Report:

Lake Projects:

- All grants applied for are funded: county-wide AIS control, Knotweed control, Apple River Flowage planning, Church Pine/Round/Big Lake planning grants.
- Runoff control pond at Pipe Lake has a failure of the berm around the outlet pipe. The contractor has agreed to fix it at his expense.
- Balsam Lake millpond box culvert design and plans are expected to be finalized soon, then the permit approval process will begin.
- The Department has been working with Bone Lake on several water quality issues including runoff control ponds and erosion control sites.
