Chairman Johansen called meeting to order at 9:30. Motion (Jepsen/Brown) to approve the Agenda. Motion (Rattel/Jepsen) to approve the April minutes. Both motions carried unanimously.

WDNR Targeted Runoff Management (TRM) Grant Resolution (discussion/action)

- Information Education Coordinator/ Water Quality Specialist position update we interviewed 6 candidates. Hope to offer position to the top candidate soon.
- LWRD Conservation Planner continues to meet with farmers in the Farmland Preservation Program to review their soil conservation and nutrient management plans.
- Response from DATCP regarding the Farmland Preservation county-wide planning grant: they want contract signed without exact dollar figure and without going forward since grant amount was not approved by the state yet.
- LWRD Engineer is still working on several projects including a new box culvert (bridge) at the millpond in Balsam Lake, a runoff control pond near Bone Lake, projects on Blake and Pipe lakes, and working on dam improvements for Burnett County.
- Tree sales are done for another year, which totaled about 25,000 trees.
