<u>Updates on Nonmettalic Mine Reclamation Financial Assurance.</u> Tim discussed that the financial assurance of \$600.00 per acre to reclaim is not enough. The state average suggests it should be at least \$3,500.00 per acre. Peter DeJardin, who administers the program joined the meeting to discuss this with committee. It was determined that the deadline for this change will be July 31, 2011.
