Call To Order: Chairman Johansen called the meeting to order at 9:39 am.

**Approve Agenda:** Motion made (W. Johnson/Brown) to approve the agenda. Motion carried unanimously.

**Approval of Minutes of Previous Meeting:** Motion made (Brown/T. Johnson) to approve June 13 minutes. Motion carried unanimously.

# Public Comments: None

**Wildlife Damage Program:** Cindy Blonk handed out and discussed the 2013 Polk County Wildlife Damage Budget. This budget, broken down into categories, is more reflective of monies spent for program. Because bear damage has been increasing, that amount will be reflective next year. Motion made (Jepsen/T. Johnson) to approve funding the Wildlife Damage Program. Motion carried unanimously.

Blonk also discussed the deer donation program. Polk County has three food processing plants who have agreed to process donated deer with processed venison going to Polk County Food Shelves. Motion made (Jepsen/W. Johnson) to have Polk County continue with the deer donation program. Motion carried unanimously.

**LWRD 2013 Budget Review:** Ritten reviewed the Land and Water Resources Department (LWRD) budget with the committee, discussing the revenues received from DATCP, grants, fees, tree program (which pays the department's educational programs), contracted services, and other programs, along with expenses associated with each program. Discussion held on replacement of engineering truck for the department's CIP (Capital Improvements Plan).

**Voucher Review and Financial Reports:** Ritten handed out and explained the two months of expenses for department. In addition to the voucher review, Ritten discussed the quarterly report stating revenues have been greater than expenses for the first half of the year.

**Agency Report:** Aaron Moore, FSA Director, discussed the Farm Bill, CRP signup and the disaster relief for maple sap producers. Due to the spring weather, maple sap was greatly reduced so maple sap producers are allowed emergency low rate loans to assist their business. Because of Polk County's moisture levels, this area was not considered a drought area, but a hay list has been started by UW-Extension to assist others in the state.

## Director's Report:

Lake Projects:

- Department working with Bone Lake on several water quality issues including runoff control ponds and erosion control sites.
- Jeremy and Katelin continue with the lake surveys and water testing they need to do for the grant projects they are working on.

### Agriculture Projects:

- UW-River Falls received a grant to collect, measure and analyze runoff from the edge of farm fields and will work with Polk County LWRD to conduct the study. Test fields have been selected.
- Soil sample information has been collected on approximately 3300 acres (30%) of the Horse Creek watershed for the Cedar Lake grant.

### Education Projects

- Polk County Association of Lakes and Rivers (PCALR) met June 20 with 8 county board supervisors attending. Ritten gave a presentation on what LWRD does and some of the threats that face Polk County lakes.
- Tim Ritten and Katelin Holm attended Northwest WI Lakes Conference on June 22 with an AIS educational display.
- Tim Ritten attended and had an educational display at the White Ash Lakes Fair on June 23.
- Soil judging contest is October 9 with Polk County hosting.

## Miscellaneous Projects

- Northwest Wisconsin Land & Water Conservation Association Area meeting and Tour is August 17 in Ashland.
- Big Blake Lake Protection and Rehabilitation District has requested a district boundary change.
