Chairman O'Connell called the meeting to order at 8:30 a.m. Proper notice was made of the meeting.

Update on Comprehensive Ordinance Re-write – Discussion with Tim Anderson, County Planner.

**Kraemer SEP Appeal Update** – Discussion. McCurdy shared an email from Malia Malone, Assistant Corporation Council, stating that the Court set the following deadlines:

September 10<sup>th</sup> – Discovery must be completed October 29<sup>th</sup> – Kraemer's Brief Due November 30<sup>th</sup> – County's Reply Brief Due December 15<sup>th</sup> – Kraemer's Final Rebuttal Brief Due March of 2011 – Expected decision from Court

**2011 Land Information Budget & Staffing**– Discussion with Sara McCurdy regarding office reorganization to add the real property listing job duties while retaining existing services. Further discussion on round two budget and staffing with the addition of the real property listing levy dollars and revenue, along with the special assessment fee for private sewer systems.
