**Discussion Ag Lime:** Due to increased demand this year for lime, inventories of lime are very low. Discussion held on possible use of a temporary crusher. Due to warm, dry fall, many are spreading lime now instead of spring.

**Sales** – Discussion held on the financial feasibility study Peterson did on 60-69 lime versus 50-59. Because of the added expenses making 60-69 (and its slight margin of benefit over 50-59), discussion was held on the possibility of producing only 50-59 lime.
