Pat Schmidt asked how many Adult Protection positions are in Polk. There are three in Polk and they have ongoing cases. Laura was asked about the responsibility of the added staff. Laura is not concerned about the APS staff supervision, as she has done for the past fifteen years in Burnett. Laura thinks it is do able; however, her preference is to wait until the beginning of summer and she would prefers not take it on until then.

Ms Stoneking indicated she would like to pursue it to see how it works out and spring would be good. Laura states that most of it would be her time. It sounds good in principal right now. It is a good match the staffs are working together; now they go out on home visits together as needed.

Mr Jepsen asked if it would make it smoother for them to be in with ADRC as they are all very aware of what we do. Coverage would be a big help in both units. The Adult Protection Specialist/I & A would give us duel coverage. Laura did not want to pursue this any further without knowing the board's openness to the idea.

Ms Poretti asked if it is necessary to move with this regard in Burnett at this time? Laura indicated, it is working in Burnett the way it is,

Laura will let Sherry Gjonnes know that the idea was welcomed and get a little more detail as to what a contract will look like. Should we put it on the full board next time? Yes, probably a good idea.

Chair Freese asked that we please do away with the acronyms on the agendas as some do not know the acronyms and it would just be easier.

In November, Washburn County had expressed an interest in sharing a Disability Benefit Specialist position with Burnett Co. If we could pull the Adult Protection Service persons in then that would give us an option of a back up person for the I & A position.

Laura does not want to share a Disability Benefit Specialist with Washburn County, at this time. The person that is currently in that position she does not want to share with the other county. We will try to look at a bigger picture then just splitting the one person.

Laura explained that Andrea Jerrick will not be here to do it but Darlene Kusmirek will be here and Laura will call Darlene down. It was agreed to bypass this segment and go on to the rest of the Agenda.
