# COUNCIL ON AGING May 11, 2010

The Polk County Council on Aging met in conference room A & B in the Polk County Government Center in Balsam Lake on May 11, 2010.

<u>Call to Order</u>: William Johnson called the meeting to order at 8:30 am.

<u>Introductions</u>: The group introduced themselves to each other.

Selection of Committee Officers: Chair and Vice Chair:

Chairman Johnson opened nominations for Chair. **Nomination for Pat Schmidt** (Stachowski and J. Nelson) as Chair of the committee. Motion to close nominations (Johansen/Kremer-Hartung). All in favor for Schmidt as Chair. Motion passed. All in favor.

<u>Financial Report and Bills</u>: The fund balance for March was handed out to the group along with an acronym chart for the fund balance. The current bill list was distributed. **Motion by Stachowski second by J. Nelson to approve the fund balance for March along with the bills for May 2010. Motion passed. All in favor.** 

<u>Public Comment</u>: Supervisor Luke shared the interest in attending today's Council on Aging meeting to learn more about the programs provided by the department.

Committee Orientation: Older Americans Act: Department Programming Overview, Duties and Responsibilities of the Council on Aging: Flom distributed a packet of materials on the Older Americans Act, the Wisconsin Elders Act, the programs provided by the Aging department along with the job description for the Council on Aging and the

duties and responsibilities of the committee. Discussion was held on the information and maps showing estimates of the aged 60+ population for Wisconsin were distributed to the group.

<u>2009 Annual Report</u>: The draft copy of the 2009 Annual report was distributed to the Council on Aging members. Flom briefly went over the contents and discussion was held on the draft. **Motion by Karr second by J. Nelson to approve the 2009 Annual report for the Aging Department and move it forward to the County Board. Motion passed. All in favor.** 

<u>Upcoming Out of County meetings</u>: The out of county meeting calendar was handed out to the Council on Aging members. **Motion by J. Nelson second by Johansen to approve the out of county meeting calendar. Motion passed. All in favor.** 

<u>Information</u>: Flom handed out a copy of a compliment/thank you from a home delivered meal participant's daughter. Flom distributed a thank you from Interfaith Caregivers for the funding for the home chore program.

Flom shared information regarding working together with Colleen Foxwell of the Library Federation in regards to grant writing. One grant has been submitted with another one due at the end of May. Foxwell has searched for additional grant areas and letters of interest will be sent out to those foundations.

Foxwell is presenting at some of the meal sites during Older Americans Month. She's presenting the topic Remembering Music. Our thanks go out to Foxwell for providing information and entertainment at some of the meal sites.
