She also had data regarding other Wisconsin counties board size, population and number represented by each supervisor.

Who is the Organizational Committee?

- $^{\circ}$ an ad hoc committee making recommendations, if any, for changes to the organization of Polk County government
- ° which must work within state statutes
- ° to work toward a more efficient and effective county government organization
- ° made up of seven county board members with officers noted previously

- ° data gathering and information sharing purposes
- ° are to inform and involve stakeholders of committee findings
- ° are to serve as a resource for the administrator

What does this ad hoc committee hope to accomplish?

- ° help to decide the number of county board supervisors
- ° to examine the benefits, if any, of staggered terms for supervisors
- ° define the roll and responsibilities of the county board chairman within the county administrator form of government
- ° examine size of committees and the basic responsibilities of each committee within the county administrator form of government
- ° examine and evaluate effectiveness of current policies
- ° examine and update Polk County Rules of Order

What are some concerns of the ad hoc committee?

- ° being transparent, having good communication with the board and public to ensure success
- ° others may not support committee products so committee needs to be open and willing to accept other ideas
- ° committee activities be accurately and fairly reported to the public by the media
- ° the process is likely to be slow

Rattel suggested, and the committee agreed, to have Administrator Frey set the date of the next meeting at his convenience and attend to advise the committee on various issues.
