Veterans Service Report

The person who filled the initial temporary position requested and approved earlier this year has resigned. The Child Protective Services unit is seeking approval to hire another temporary employee to assist with the CPS caseload.

Discussion ensued on the need to request a full-time position, which will be part of the upcoming Staffing Plan.
