The Land Conservation Committee met January 13, 2010 in the County Board Room.

Supervisors Present: Larry Jepsen, Kathryn Kienholz and Ted Johnson, FSA Representative.  
Diane Stoneking and Dean Johansen were absent.

LWRD Staff: Tim Ritten and Becky Burkhardt; Rebecca Fredrickson took minutes.

8:37 a.m. Chairman Jepsen called the meeting to order. **Motion (Johnson/Kienholz) to approve the Agenda. Motion (Kienholz/Johnson) to approve the December minutes. Both Motions carried.**

**Public Comment.** Jean Schermer – Laketown Township Resident, discussed the status of the case re: Holly Bergstrom et. al., plaintiffs vs. Polk County and Mathy Construction, defendants.

**Agency Reports.** Keith Zygowicz – NRCS. Laura Bratz' last day is Feb. 28<sup>th</sup> and March 1<sup>st</sup> Chris "Lars" Olson will begin working at the Balsam Lake office. EQIP and WHIP will start January 19<sup>th</sup> and run through February 19, 2010. "Seasonal High Tunnels" (hoop houses used for seasonal garden crops, approximately 75' x 25', paid \$1.86 sq. ft.) is an added new practice.

**Wildlife Damage.** Cindy Blonk handed out suggested 2009 wildlife damage crop reimbursement rates for review. **Motion (Johnson/Kienholz) to use the suggested rates presented for the 2009 Wildlife Damage Program Crop Reimbursement rates. Motion carried.**

**Burnett Contract.** The contract for technical services was discussed. **Motion (Kienholz/Johnson) to accept the Burnett County 2010 contract, signed by Larry Jepsen. Motion carried.**

**Land & Water Resource Management Plan (LWRM).** At the County Board January meeting, Tim is on the agenda re the Resolution to approve the 2009 LWRM Plan and will also be making a presentation.

**Voucher Review.** **Motion (Kienholz/Johnson) to approve the voucher report for Dec. 2009. Motion carried. Motion (Johnson/Kienholz) to approve the Jan. 2010 voucher report. Motion carried.**

### **Director's Report.**

- WLWCA Annual Meeting – Tim was unable to attend; Larry Jepsen gave an update. A one-time \$800 special assessment will be sent to all counties (to help fund the Executive Director)
- WAL – The annual meeting will be March 30 – April 1, 2010
- Job Approval Authority for Tim – requires signature of Larry Jepsen
- Kronos Time Keeping – Tim pointed out the system cannot do what LWRD must have for recordkeeping at this time
- Working Lands Initiative – Eric W. attended a recent meeting in Tomah; staff coordinated a meeting January 11<sup>th</sup> on Ag Enterprise Areas, held at the Star Prairie Community Center; and in 2 weeks a meeting will be held at the Alden Town hall - discussion
- Laketown Quarry – Court of Appeals entered an order granting the petition for leave to appeal
- Kraemer Mine – the Land Information Committee denied the Kraemer application
- The Polk Co. Towns Association is holding a meeting at 7 pm January 28, at the Justice Center and will discuss the Working Lands Initiative; representatives from Laketown and Osceola will give an update on nonmetallic mining in their towns
