## **Polk County Land Conservation Committee**

The Land Conservation Committee met February 10, 2010 in the County Board Room.

Supervisors Present: Larry Jepsen, Kathryn Kienholz, Diane Stoneking, Dean Johansen and Ted

Johnson, FSA Representative.

LWRD Staff: Tim Ritten and Becky Burkhardt; Rebecca Fredrickson took minutes.

8:43 a.m. Chairman Jepsen called the meeting to order. **Motion (Johansen/Stoneking) to approve the Agenda. Motion (Stoneking/Johnson) to approve the January minutes. Both Motions carried.** 

Public Comment. None.

<u>Agency Reports.</u> Keith Zygowicz – NRCS. The last day of regular EQIP signup will be February 19, 2010; \$58,000 for cropland practices and \$11,000 for pasture land practices within Polk County. Laura is being assigned to Janesville the end of February and Chris "Lars" Olson will begin here March 1<sup>st</sup>.

<u>Wildlife Damage.</u> Cindy Blonk presented the 2009 Wildlife Damage Claims summary, noting the numbers are down about 50% from last year. There are 21 claims approved and ready for payment and 3 pending claims to be discussed next month. **Motion (Johnson/Kienholz) to approve the 2009 wildlife damage claims totaling \$40,800.82. Motion carried.** 

<u>Presentation</u>. Eric Wojchik, Conservation Planner for LWRD, explained the Working Lands Initiative – Ag Enterprise Areas (a modified Farmland Preservation program) by showing a PowerPoint presentation. The St. Croix County LCD and Polk Co. LWRD, along with Tim Anderson – County Planner and Ryan Sterry – UW-Extension are working together with a large group of interested ag landowners on the Squaw Lake Ag Enterprise Area application. The deadline to file the application with DATCP is February 26, 2010. Discussion and question/answer dialogue. **Motion (Kienholz/Stoneking) to sign the letter of support document for the Squaw Lake Ag Enterprise Area Application. Motion carried.** 

Coon Lake Grant. Tim discussed the projects proposed in the grant application Jeremy Williamson has submitted to the DNR. Motion (Stoneking/Kienholz) to approve the resolution authorizing the Coon Lake Planning Grant Applications for (1) Water Quality and Stormwater Management Study and (2) Biological Monitoring Study and Community Education and send the resolution to the Polk County Board. Motion carried.

<u>Voucher Review.</u> Motion (Stoneking/Johnson) to approve the voucher report for \$2,540.86. Motion carried.

### **Director's Report.**

- WAL The annual meeting will be March 30 April 1, 2010. Jeremy W. is a presenter.
- The Polk Co. Towns Association meeting Jan. 28<sup>th</sup> had a speaker discussing the Working Lands Initiative; reports on mining from the Towns of Laketown and Osceola were also given.
- Tim will propose new fees for nonmetallic mining guarries.
- Sheila Harsdorf letter to Tim re FPP: a copy of the proposed bill that would cover the pending FPP applications that were denied when the June 30<sup>th</sup> budget was passed and DATCP ended pending FPP applications.
- Kronos Tim pointed out the system cannot perform LWRD necessary recordkeeping functions at this time, specific current issues, Kronos information from other county conservation offices, etc.
- Letter of Intent LWRD CCAs working with NRCS is being considered; update later.
- WALCE Peter and Eric will be attending the WALCE conference March 3-5.
