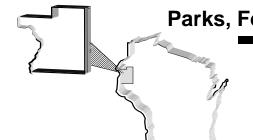

### Motion to accept the agenda by Neil Johnson, 2<sup>nd</sup> by William Johnson. Motion carried

Discussion of the Parks Department purchase of a used snowmobile for grooming ski trails and other use of the Parks Department from William Johnson and the Viking Ski Club of Frederic. The offer was made in 2009 before Johnson was on the County Board, and the funding was included in the 2011 CIP Budget of the Parks Department. This was in compliance of disclosure to prevent any implied conflict of interest.

Motion to approve the purchase of the snowmobile from William Johnson/Viking Ski Club was made by Ken Sample and  $2^{nd}$  by Larry Jepsen. Motion carried, with William Johnson abstaining from the vote.
