

Polk County Property, Forestry and Recreation Committee – November 8, 2010

The Polk County Property, Forestry and Recreation Committee met in the County Board Room of the Polk County Government Center.

Members Present: Larry Jepsen, William Johnson IV, Ken Sample, Neil Johnson, Diane Stoneking

Committee Chair Jepsen called the meeting to order at 1:30 p.m.

Accept Agenda: Motion (Sample/Wm Johnson) to approve the agenda. Motion carried by voice vote.

Approval of Minutes: Motion (N Johnson/Sample) to approve the minutes from the September 13, 2010, meeting. Motion carried by voice vote.

No public comments.

• FORESTRY

Forester Jeremy Koslowski distributed and discussed a report of his activities between September 13th and October 8th. He also distributed the Polk County Forest Annual Work Plan for 2011.

Motion (Wm Johnson/Stoneking) to approve the Polk County Forest Annual Work Plan 2011 and forward it on to the full county board for approval. Motion carried by voice vote.

Koslowski distributed information regarding five timber sales which have been let out for bid. Bid deadline is at noon on Monday, December 6, 2010.

DNR Forester Paul Heimstead distributed and discussed information regarding age distribution of jack pine, aspen and scrub oak in Polk County forests.

• TREASURER

Polk County Treasurer Amanda Nissen reported that she has been working with Jeff Fuge, Debbie Peterson and the Sheriff's Department to send out eviction notices on tax deed properties.

Debbie Peterson opened the one bid received for the Town of McKinley property. The bid was in the amount of \$119,675.

Motion (N Johnson/Stoneking) to reject the one bid that was received and let out bids for the property again in the spring. Motion carried by voice vote.

Jennifer Williams, Director of Kinship, addressed the committee. Because they work closely with Human Services Department, they are looking at the possibility of relocating the Kinship offices back to Balsam Lake. Current the Kinship offices are located in the Amery City Hall.

Peterson reported that Endeavors has proposed to do the cleaning of their building with their staff. Peterson continues to work with Focus on Energy to reduce energy costs for them.

Museum is closed. Parks are closed.

• DIRECTOR'S REPORT

Focus on Energy meeting, DNR trails inspections, scrap and green glass for reclamation at the lime quarry, purchasing an oil filter crusher with the highway department to reclaim oil and sell the metal as scrap, Land and Water department sharing software with the forester in return Jeremy will train Land and Water personnel how to use the software, storm damage the old sheds got a new skin, a rooftop unit was placed on the old jail building last week, and Jeremy, Jerry Johnson and Debbie will attend a Dam Safety meeting next week.
