

Amery Fire Dept will be holding a HazMat Operations Level refresher beginning on January 17 and concluding on February 14.

Dresser-Osceola-Garfield Fire department will be holding a HazMat/WMD Terrorism Awareness

refresher on August 22 and a HazMat Operations Level refresher on August 23 & 24. Osceola Area Ambulance has applied for two classes, a HazMat Awareness level class to be held in June and a Confined Space Entry class to be held in August. These classes are pending approval for funding from Wisconsin Emergency Management. Kathy also reported that she had been notified that Polk County was awarded OJA grant funds to host a Critical Incident Stress Management course for local emergency responders and volunteers. Kathy is trying to confirm the dates and will then be recruiting for the class.
