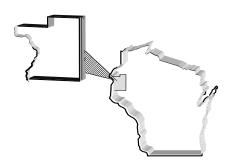

Consideration of HMEP Grant Application

Kathy presented the application for a multi-county Hazardous Materials Emergency Planning grant requesting funds to conduct a Commodity Flow Study. The Counties participating in this proposed project are Polk, Barron, Burnett, Rusk and Price. Polk County Emergency Management has received approval to be the lead agency. Motion made by Tim Strohbusch and seconded by Gail Peterson to approve the grant application as presented and recommend the submission to Wisconsin Emergency Management for consideration. Motion carried by unanimous voice vote.

<u>Update on Training/Exercising</u>

Kathy presented the Training summary sheet for review. Kathy reported that one new application for training had been received since our last meeting. The Osceola Medical Center was approved for four HazMat Operations Level Refresher classes. The training was held September 18, 19 and 20th, 2012 with 31 students successfully completing the class.
