Dana Frey gave the Medical Examiners report. For February, 22 natural deaths, 1 accidental, 2 autopsies and 21 cremation permits.

Clerk of Courts, Lois Hoff reported that foreclosures are up. She has employees off due to sickness and vacations.

Sheriff Pete Johnson presented four officers with awards, Deputy Nick Bryant and his K9 Kaiser, Jail Sgt Sarah LaVenture, Sgt Mike Stoffel and Osceola Officer Belcourt. In February 118 inmates were booked, 112 released, 115 seen for sick call. Average daily population was 86. 90% of the fees were collected. Vehicle towing for the county was discussed.

Jeff Fuge gave the monthly cash flow analysis for Child Support. He passed his departments goals for 2012. They will be discussed at the April meeting.

Closure of Polk County Offices due to inclement weather was discussed.
