Chairman Luke called the meeting to order at 2 P.M.

Motion Masters/Edgell to approve the agenda. Carried.

Motion Masters/O Connell to approve the July minutes. Carried.

Belinda Cash from the District Attorneys office presented their District Attorney/Victim Witness budget and fee schedule.

Medical Examiner Jonn Dinnies presented his 2012 budget which showed a reduction of \$2326.00. In July there were 24 cases, 17 were cremations. There were 4 autopsy, 2 drownings, 2 suicides, 1 child accident with 2 undecided. 161 total cases for the year.

Clerk of Court, Lois Hoff will present her budget and fee schedule in September.

Steve Moe gave the Sheriffs report. The law enforcement budget is down about 2%. The fee schedule was presented. The average daily jail population in July was 92. Twenty four hours of training a year is required. Much is done in house.

Jeff Fuge discussed the Corp Council/Child Support budget. This showed a reduction of 2%. Also discussed was the position of Child Support Lead Worker. The monthly cash flow analysis for Child Support was presented. Mr. Fuge is asking for additional levy for the lead worker position.
