Motion Masters/O Connell to approve the November minutes. Carried.

District Attorney Steffen reported that meth use is up in the county. Not meth related there were 96 cases in November. 1121 for the year. It was noted that the State Attorney General has reduced funding for the Sexual Assault Victim Services program.

Jonn Dinnies, Medical Examiner, had 17 cases in November. Two autopsies, one homicide from 2007, one suicide, fifteen natural. Twelve cremation permits were issued. 259 cases for the year. A year ago 263 cases.

Sheriff Johnson reported November numbers. 221 cases, 1099 incidents and 2414 calls for service. Scott Nargis introduced his new jailer, Stacy Petacek. The average daily population of the jail was 92 in November with 68% of fees collected. 131 inmates seen for sick call. Steve Moe discussed the Cumberland McKinley tower lease agreement. Motion O Connell/Masters to send to the County Board a resolution to Adopt Amendment to Structure Lease Agreement for Cellular Communications Tower. Motion carried.

Jeff Fuge gave a report on Bureau of Child Support Resonse to Single County Audit, negative finding. The agency staffing analysis was presented as well as the monthly cash flow analysis.
