Minutes of January 12, 2012 Meeting

Chairman Timm Johnson called the meeting to order at 3:05 p.m.

Present were county board supervisors Jay Luke and Kathryn Kienholz and citizen members Marlin Baillargeon, Joe Cronick, Gary Dado, Gregg Westigard. Supervisor Kim O'Connell was absent.

Also present was Tim Anderson, Polk County planner and Deb Peterson, Polk County Parks and Property director.

Motion by Dado/Luke to approve the agenda; carried by voice vote.

Motion by Baillargeon / Luke to approve the minutes of the December 15th meeting; carried by voice vote.

Public comments.

Tim Anderson advised the committee that he had not be able to find any grant funds to assist with lighting or electricity evaluation at the Justice Center.

Deb Peterson reported that she had a meeting with the representatives of the LT Solutions Corp. on LED lighting at the Justice Center – details below.

Waste oil furnace at the recycling center.

Tom Engel passed out his proposed narrative and analysis for the Waste Oil Furnace project tat the Recycling Center. The committee had a brief discussion on the project and possible alternative ideas as well as the project timeline.

Motion by Westigard/Kienholz to forward the project to the Parks and Property committee and Finance Committee for approval recognizing that the project will need to be formally bided; carried by voice vote.

Energy Usage at the Justice Center.

Deb Peterson reported on her meeting with the LT Solution's representatives, she has given them the lighting plans and she is expecting a report or proposal from them. She also stated that significant lamp changes, relamping and delamping have been completed at the Justice Center.

County Purchasing Policy.

Gregg Westigard reported on the initial defeat of the purchasing policy change and what changes have been made to make "Energy usage when significant" apart of the policy. It is expected to be reviewed at the next board meeting.

Members Comments.

Deb Peterson reported that Northwestern Electric Company has ordered the new demand metering equipment for the Justice Center and that GAM lighting is being changed. Tom Engel advised the committee that Geronimo has setup at "Metrological Tower" between Centuria and Milltown. Timm Johnson reported little progress on the CNG facility in Osceola.
