- II. Review, evaluate and update 2010 25 X 2025 Plan for Energy Independence (Champion: Kathryn Kienholz)
  - ♦ Invite key stakeholders to help review 25x25 projects; determine status of each
  - ♦ Communicate & provide outreach of plan & what was learned; determine next steps

#### Minutes of May 17, 2012 Meeting

Chairman Timm Johnson called the meeting to order at 3:05 p.m.

Present were county board supervisors Tom Engel, Kathryn Kienholz, Jay Luke and citizen members Marlin Baillargeon and Joe Cronick. Citizen members Gary Dado and Gregg Westigard were absent.

Also present was Tim Anderson, Polk County planner and Bob Kazmerski, UW Extension Community Resources agent, Deb Peterson, Property Director.

Prospective citizen member Dave Mueller was also present to observe.

Motion by Kienholz/Luke to approve the agenda; carried by voice vote.

#### **LED Lighting proposals:**

Tom Engel reported that he was going to contact the sale representative for the LED Parking Lot lights at the Justice Center. He also said that he had also spoke with LT Solutions and learned that they will have a parking lot bulb available within the next 2 months.

Deb Peterson was of the general opinion that we should do addition research and evaluation and strive to purchase LED bulbs when retail prices drop. Deb also agreed to look into the possibility of installing a demonstration bulb(s) and obtain accurate electricity usage between present fixtures and LED fixtures.

## Waste oil furnace at the recycling center:

Deb Peterson reported that she has been in discussions with Scott Robinson from Chippewa Valley Alternative Energy to review furnace sizing.

Marlin Baillargeon reported on the possibility of a newly available combination propane/waste oil burning furnace which maybe appropriate if there were ever a shortage of waste oil fuel.

## **Strategic Planning:**

Bob Kazmerski reviewed the REC short term, medium term and long term 2012-2013 goals. He provided REC members with copies of the 2012-2013 Goals and Objectives so members can work toward those goals that they are the champion. It was also agreed to have brief review of the goals at most meetings.

#### **Members Comments:**

Timm Johnson reported on the joint Osceola/Polk County Energy Independence workshop and the CNG meetings held in Osceola last month.

A portion of the Energy Independence Team grant, educational component, was use to provide some school bus reimbursements to those districts that bussed students to the event.
