Minutes of June 21, 2012 Meeting

Vice Chairman Tom Engel called the meeting to order at 3:05 p.m.

Present were county board supervisors Tom Engel, Kathryn Kienholz, Jay Luke and citizen members Marlin Baillargeon, Joe Cronick, Gary Dado, and Gregg Westigard.. Citizen member Timm Johnson was absent.

Also present was Tim Anderson, Polk County planner and Bob Kazmerski, UW Extension Community Resources agent, Deb Peterson, Property Director. Prospective citizen member Dave Mueller was also present to observe.

Gary Dado agreed to record notes for the meeting.

Public comments:

Tim Anderson presented the Polk County's Letter of interest in the Grant Opportunity to participate in the fleet analysis and fuel reduction usage strategies that Dana Fry submitted on behalf of the county.

Jay Luke reported on the very successful usage of canola seed diesel fuel by the Town of Lincoln.

LED Lighting proposals:

Tom Engel reported that he had not made contact with the sales representative for the LED Parking Lot lights at the Justice Center.

Marlin Baillargeon reported that he had spoken with Dan Wiess of LT Solutions and that they were prepared to provide 24-36 LED bulbs to county free of charge. Deb Peterson suggested, and the committee concurred to accept the offer and to make an electrical usage installation at the shop in the highway department. It is expected that it will be possible to actually measure the electricity usage (hopefully savings) between the LED bulbs and the present metal halide bulbs.

Waste oil furnace at the recycling center:

Deb Peterson reported that had been no further discussions with Scott Robinson from Chippewa Valley Alternative Energy to review oil furnace sizing.

Marlin Baillargeon will try to get a meeting scheduled with Deb Peterson and Scott Robinson. Note: Subsequent to this REC meeting, an oil furnace meeting als been scheduled for July 10th.
